



# Mark, seal, and sign your envelope



## 1. Mark your ballot

- Follow the directions on the ballot.



## 2. Seal and Sign the envelope

- Put your ballot into an envelope and seal the envelope.
- Date and sign your name on the ID Envelope image.
- **Print your name and Orange County Residence Address, as it appears on your registration affidavit.**

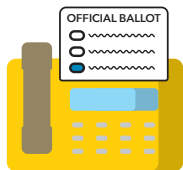
## 3. Options for returning your ballot

### BY MAIL



- Place your voted ballot in an envelope.
- Cut out the ID Envelope Image and glue or tape it to the envelope containing the voted ballot.
- If you desire, you may place this ID Envelope in a larger envelope for mailing.
- Your envelope must be signed, dated, and postmarked on or before Election Day and received by the seventh day after Election Day.
- You may mail your ballot to: 1300 S. Grand Ave., Building C, Santa Ana, CA 92705 or P.O. Box 11298, Santa Ana, CA 92711.

### BY FAX



- Complete the ID Envelope and Oath of Voter form.
- Fax your ballot, Oath of Voter form and ID Envelope to (714) 333-4488.
- **Our office cannot accept your faxed ballot without the Oath of Voter form and the ID Envelope. Your faxed ballot must be received by 8:00 p.m. Election Day.**

## Important additional info!

- Ballots received by email will not be accepted.
- Please be sure to allow for sufficient time to either fax or mail your ballot back to our office.
