IMPORTANT: Read these instructions carefully before completing the statement. Failure to follow these instructions may cause your ballot not to count.

- 1. In order to ensure that your vote-by-mail ballot will be counted, your statement should be completed and returned as soon as possible so that it can reach the elections official of the county in which your precinct is located no later than 5:00 p.m. **September 22, 2021**.
- 2. You must sign your name on the line above (Voter's Signature).
- 3. Place the statement into the postage-paid Business Reply Mail envelope provided. Mail, deliver, or have the completed statement delivered to the elections official.
- 4. You may submit your completed statement by mailing it to: 1300 S. Grand Avenue, Bldg. C, Santa Ana, CA 92705, by email at ocvoter@rov.ocgov.com, by fax to the Registrar of Voters' office at (714) 567-7556 or (714) 333-4488, or submit your completed statement to any Vote Center or ballot drop box in the County before 8:00 p.m. on Election Day.
