Ballot Measures-E

Impartial Analysis City of Westminster Measure E

This measure, which was placed on the ballot by the Westminster City Council, proposes to change the term of office for mayor from a two-year term to a four-year term. The measure requires a majority vote of the electorate.

Currently, Westminster city council members are elected to a four-year term, while the mayor is elected to a two-year term. If approved by a majority of the voters, the measure would standardize the terms of office for all members of the City Council and the mayor would serve a four-year term like all other city council members. If approved by a majority of the voters, the measure would amend Section 2.04.100 to change the two-year term of office for the mayor to a four-year term. This change would become effective at the expiration of the current mayor's term of office, which will occur in November 2018. If approved by a majority of voters, the person elected mayor at the November 2018 election would serve a four-year term.

A "yes" vote is a vote in favor of changing the mayor's term of office from a two-year to a four-year term. A "no" vote is a vote against authorizing this change.

Ballot Measures-E

Argument in Favor of Measure E

Measure E is a common-sense reform to Westminster's city government. Measure E does one simple thing: change the term of Mayor from 2 years to 4 years.

By taking this simple action, Measure E changes our city for the better:

- Curb the power of special interests in Westminster
- Reduce City government dysfunction
- Focuses the Mayor on governing, not campaigning

Under a 2-year term, the **Mayor needs to raise twice as much money from special interests** because the Mayor has to run twice as many elections than he or she would with a 4-year term. **Measure E puts a stop to this!**

The Mayor of Westminster should not be endlessly campaigning for office and begging special interests for campaign contributions. Westminster needs the Mayor to be doing his or her job as the leader of our city, not constantly raising campaign contributions and running for re-election.

Every local government office Westminster residents vote for has a four-year term: County Supervisor, District Attorney, Sheriff, County Treasurer, County Auditor, County Assessor, County Clerk-Recorder, County Superintendent of Schools, City Council Member, School Board Member, Water Board Member, and even Sanitary District Board Member.

Measure E makes it clear that the Mayor of Westminster should not be any different than any other local government office.

The only other offices Westminster residents vote for with 2-year terms are State Assembly and U.S. Congress. Westminster needs government that works, not the wasteful broken government provided by the State Legislature in Sacramento or the U.S. Congress in Washington.

Vote "Yes" on Measure E to keep Sacramento and Washington's dysfunction out of Westminster.

Vote "Yes" on Measure E to curb the power of special interests in Westminster.

Vote "Yes" on Measure E for common-sense reform in Westminster.
